

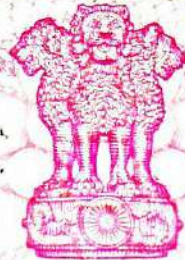



It is important for both parties to this agreement to be reasonable in every aspect of activity undertaken by both parties to achieve common goals .


